In accordance with PA 283 section 224.19(b), telecommunications/video communications provider permit fees are limited to \$300.00 per permit, or \$1,000.00 for all permit fees per project. A project is limited to a permit application which has been submitted by one applicant as a package of work, similar in nature, to be accomplished in one year, along one road; a project may include a minor amount of work by one applicant of similar nature, along contiguous road segments to be accomplished in the same year.

**SIGNS**

Sign Cost - \$225 Includes sign, post & installation.

PLAN REVIEW - Base rate + \$5 per lot. For new developments where new roads will be taken into the county road system. \$150.00 (Base rate)

LOT SPLITS - Base rate + \$5 per lot. (Private Road Permits can be obtained at the same time the lot split is approved, for no additional fee, if the road will be constructed this calendar year by the applicant). \$50.00 (Base rate)

**SPECIAL EVENT FEES FOR USE OF THE PUBLIC ROAD RIGHT-OF-WAY**

Sponsored by a documented Non-Profit organization	\$ 0.00
Sponsored by a for profit organization - 0 to 249 participants	\$ 250.00
Sponsored by a for profit organization - 250 or more participants	\$ 500.00

By state law any organization wishing to close or partially close a County Highway must first obtain permission from the appropriate Township Board(s) of Trustees, who then must request the Benzie County Road Commission issue a permit per Act 200 of 1969, MCL 247.323

The permittee is responsible for the cost of any and all traffic control devices deemed necessary by the Benzie County Road Commission regardless of non-profit or for-profit status. The Benzie County Road Commission does not supply/rent/lend traffic control devices of any type for Special Events.

The permittee must also meet all current insurance requirements.

ABANDONMENT - \$250 deposit applied to actual cost (requester pays for all costs of advertising, verification, etc.)

FREEDOM OF INFORMATION REQUEST - Charges are determined by law.
