December 23, 2021 regular meeting minutes were approved.

Motion by Commissioner Bowers and supported by Commissioner Mick to pay bills #51167 to #51209 in the amount of \$54,039.90 and Payroll #1 for \$61,677.00.

Cash Summary: Reviewed – no comments offered.

**Work Summary:** In addition to offering comments on how the fleet is holding up this winter, Fleet & Facilities Manager Johnson reported that the hydraulic hoist used by the mechanics to service the fleet is worn out and should be replaced sooner rather than later. While short-term fixes can still keep the unit in service, a long-term solution should be considered. Johnson had received a rough preliminary quote for \$155,000.00 to replace the entire unit and he would like some direction from the Board how he should proceed. Also, the replacement unit would need to installed in a different spot to ensure sufficient overhead clearance and accessibility. After further discussion, Johnson instructed to proceed with efforts to replace the old unit by what the bid specifications should be, and if the item is available on the State of Michigan MiDeal or Sourcewell programs.

**Standing guest: Gary Sauer, County Commissioner** – Presented an oral report for items/issues the Benzie County Board of Commissioners is dealing with as well as events impacting local government from around Benzie County.

-Memorandum of Agreement with Grand Traverse Band – funding for Brownell culvert replacement project:

While no construction is anticipated until later this year or possibly the next, this agreement would provide funds for replacing a large drainage structure on Brownell Road, with the Road Commission doing much of the work. Skeels stated that he estimates the only cost to the Road Commission would be for limited design work on the culvert footings that should not exceed \$1,000.00.

Motion by Commissioner Bowers supported by Commissioner Mick to authorize Manager Skeels to execute the Memorandum of Agreement with the Grand Traverse Band of Ottawa & Chippewa Indians whereby the Benzie County Road Commission agrees to install/construct and maintain a culvert crossing for that part of Carter Creek flowing under Brownell Road, with the Road Commission being reimbursed upon completion and final approval, less any operations fees that may apply.

# -Approve MDOT resolution naming staff members (by title) authorized to submit permit applications to MDOT for working in the trunkline road right-of-way:

Nedow explained that MDOT was updating their records and discovered that many road commissions had submitted resolutions that authorized specific individuals by name instead of by position which would be invalid if the person named had left or retired from their respective road agencies. As such, MDOT is asking all road agencies to provide updated resolutions.

Motion by Commissioner Bowers supported by Commissioner Mick to approve MDOT form 2207B "Performance Resolution for Municipalities" for Benzie County Road Commission authorizing the Manager, Superintendent, Engineer Technician and Foreman to submit permit applications to MDOT for any work/tasks performed in the trunkline road right-of-way as needed.

#### Correspondence/Information/Discussion:

Letter dated January 4, 2022 from MSRCSIP Claims Director Wendy Hardt explaining the Open Meetings Act update. As of January 1, 2022 Board members must be physically present at a meeting of a public body in order to be counted as establishing a quorum and to vote, unless the member is absent due to military duty. In addition, meetings must be open to the public and be held in a place available to the general public but can still be make virtually available if desired.

#### **Board Round Table:**

Skeels reported on efforts to re-establish a Road Commission Safety Committee comprising of staff and union members; pursuing first aid/CPR training and other work-related training sessions. New tow-straps have been purchased to replace the heavy-duty chains that had been used to pull stuck or hung-up plow trucks free.

Skeels has also been in contact with Brad Link, who is preparing a memo on the condition of the various county bridges. The Haze Road bridge has been added to the list of locations that need to be addressed, and Skeels stated that sooner than later, the Road Commission will need to start addressing the list of bridges that need work.

### Appointment: Public Hearing: Dinger Road abandonment request:

Chairman Rosa opened the public hearing at 10:30 a.m. to hear comments on the Dinger Road abandonment request for that portion of the seasonal road between Center Road and Stanton Road as requested by adjacent property owners Steve and Joyce Blood.

Those who voiced support for the abandonment request: Steve and Joyce Blood.

Those who voiced opposition to the abandonment request: Colfax Township Clerk Audrey Swisher, who resides at 2381 Miller Road, Irene Dunham-Thayer, who resides at 2477 Miller Road and Gene Hoseit, who lives at 2407 Miller Road. Each provided their reasons for opposing the request.

Colfax Township Supervisor Ron Seguin was in attendance but did not offer an opinion to the request.

#### Written correspondence:

Nedow reported Skeels received emails from Apollo Exploration & Development Vice President Tim Hauck and Lambda Energy representative Rodney Schoolcraft regarding Dinger Road.

In an email dated December 3, 2021 Schoolcraft wrote that after discussions he had with Steve Blood, Lambda has no objection should the northern segment (Section 26) of Dinger Road is turned private from public as he opined Lambda retains its authority to use this segment of Dinger Road by virtue of the grant recorded in the Edwin P. Walter lease dated 3-9-83, and that Mr. Blood had informed him that he would move gates to accommodate Lambda's needs.

Also in an email dated January 10, 2022, Apollo Exploration Vice President Tim Hauck wrote that he had been contacted by Steve Blood concerning the abandonment of Dinger Road which his firm uses to access their well-site in section 35 south of Stanton Road. Hauck wrote Apollo would have no objections to gates being placed on Dinger Road provided Apollo had keys so that they could access their well. If the road is abandoned, Hauck requested an easement be granted to Apollo to use the road right of way until their well is plugged and abandoned.

Nedow then announced that Michigan Compiled Law states the Board has thirty days following the public hearing to make a decision on the abandonment request so that they could consider the testimony heard at today's hearing. Commissioner Bowers stated he would be absent at the January 27th regular meeting to which Chairman Rosa responded that the matter would be on the February 10th meeting agenda when the full board is expected to be present.

Motion by Commissioner Bowers supported by Commissioner Mick to close the public hearing and return to open session.

Discussion: None.

Ayes: Commissioners Rosa, Bowers and Mick. Nays: None. - Motion is hereby adopted.

Chairman Rosa then reconvened the regular session at 10:48 a.m.

Other Matters: Status of possible Henry Road relocation:

Skeels passed out a revised drawing provided by the engineering firm hired by Benzie Central Schools that depicts the south end of Henry Road on the east side of the DTE easement and that DTE did not offer any objections to the proposal provided the new road is constructed at least 25 feet from their east boundary line. Benzie Schools representative Jason Barnard and Brian Childs stated their Board supports the proposal to relocate Henry Road and their people are proceeding with drawing up an easement for the Road Commission can assume control of the new roadway. Barnard and Childs are asking the Road Commission to construct the gravel portion of the new road this spring, with paving to happen after construction is completed at some point in 2023. Further discussion ensued as to the width of the easement so that the tree removal contractor hired by Benzie Central Schools can cut/remove those trees within the proposed right of way, with a sixty-six feet width agreed upon. Commissioner Rosa stated he will support the Road Commission constructing the new road so that construction planning can continue without delay, but informed Barnard and Childs this did not include improvements such as sidewalks and lighting which the school would have to pay for.

With no more business to discuss, Chairman Rosa then adjourned the meeting at 11:08 a.m.

Whereas the Benzie County Road Commission has received a petition asking for the abandonment of the northwesterly portion of Dinger Road, a seasonal road located in Colfax Township, and

**Whereas**, in accordance with MCL 224.18, notification has been published in the Record Patriot and a public hearing on the Notice to Abandon was held during a regular meeting of the Board of County Road Commissioners on January 13, 2022 and comments objecting and supporting the request were heard, and

Whereas the abandonment of that portion of Dinger Road would not land-lock any parcel of land as the road does not abut any privately owned land that is not owned by (and part of) Steve and Joyce Blood, and

Whereas in the event the parcel is subsequently developed or split into smaller parcels, Public Act 591 Land Division Act requires the developer provide private deeded access for each newly created parcel to a public road, and

Whereas the petition applicants have signed a Release of All Claims, releasing the Benzie County Road Commission, its officers, employees, agents and insurers from any and all claims, actions, causes of actions

demands, rights, damages costs and compensation whatsoever related to property damage or personal injury, and

Whereas it appears to said Board of County Road Commissioners that it is in the public's best interest that the northwest portion of Dinger Road, between Center Road and Stanton Road should be absolutely abandoned and discontinued,

Now, therefore be it resolved that the northwesterly segment of Dinger Road, more fully described as:

The northwest segment of Dinger Road, starting at Center Road, then running south-southeasterly to Stanton Road, a distance of 0.56 miles,

All located in Section 26, Colfax Township, be and the same is absolutely abandoned and discontinued, reserving the rights of any utilities that are currently present.

**Be it further resolved** that a record of this abandonment is to be registered with the Register of Deeds and a legal notice of abandonment is to be published in the Record Patriot.

#### -Review preliminary draft "Statement of Intent-Platte River School Property":

Conceived as a general statement to provide transparency to the property acquisition process, the one-page narrative summarizes the chain of events that will eventually culminate with the Road Commission receiving the Platte River School property from Benzie Central School District. It also identifies the intended primary long term and short term plans the Board has for the property/building.

No action taken as Nedow requested the Board review the draft and offer comments/edits before adopting it at the February 24<sup>th</sup> meeting so that the document can be published on the Road Commission website.

Chairman Rosa stated that he was recently contacted by Advocates for Benzie representative Bill Ward who asked if the group could leave their office furnishings in the Platte River School building until their new facility presently under construction is ready for them to occupy later this spring. No objections were offered.

He also stated that MDOT informed him that the State Attorney General is indicating the Road Commission is to absorb the cost of construction engineering for the "fix" and not funded from the bond proceeds.

Ron Hitesman also offered comments of his experience with long delays while seeking permit approval from a regulatory agency governing river frontage for putting a picnic table at the Day Park at Black bridge.

Fleet Manager Johnson reported that as efforts to locate a contractor who would be willing to bid replacing the old and outdated floor lift, he since shifted his focus on portable units instead. Johnson was able to obtain a Sourcewell quote from Mohawk Lifts for a Gray 19,000-pound capacity portable lift for \$95,318.82. He further added that this unit is large enough to accommodate our present needs and can be moved should a new garage be built in the near future. While the current in-floor lift is still functional, he will seek quotes to remove it as soon as possible given the unit's age and questionable reliability.

Standing guest: Gary Sauer, County Commissioner - Presented an oral report for items/issues the Benzie County Board of Commissioners is dealing with as well as events impacting local government from around Benzie County.

Public Input: Heard comments from Pat Grey who asked the Board for assistance in shifting Lincoln Road, a gravel road located in Benzonia Township, back onto the section line. Grey owns an orchard that borders Lincoln Road, and because the road has shifted off the section line close to his orchard, he is precluded from erecting fencing along his property line to keep the deer out of his orchard. Grey stated he had contacted Benzonia Township Supervisor Jason Barnard to ask the township to fund the project, and has since obtained a quote from Bonney Brothers Excavating to relocate the road bed and install ditching to control the water runoff. He asked the Board if there is anyway the Road Commission would consider providing grading equipment for this project and if there were any objections to moving the road back onto the section line.

No action was taken, as Chairman Rosa stated he wanted to confer with Superintendent Fasel before giving Grey a formal response.

Powell reported the adjacent property owner on Deadstream Road, Sally Casey is refusing to cut back brush and foliage growing into the road right of way that is obscuring/limiting visibility for the neighboring Cherry Street residents accessing onto Deadstream Road. Link Engineering Services recommendation: Nostwick Road bridge – temporary structure for sale: In a memo dated July 25, 2022 to Manager Skeels, Link learned of a temporary bridge superstructure (beams, deck pan and railing) offered for sale by a contractor for \$75,000.00. This prefabricated steel structure has a span of 65 feet and width of sixteen feet which could be a cost-effective temporary solution for Nostwick Bridge. Before any decision is to be made, Link is recommending adding height to the abutments to increase clearance and thus require the approach grades to be raised as well. The southeast abutment, which is presently leaning, would have to be evaluated and stabilized before proceeding. Skeels stated he had contacted EGLE to see whether or not such a project is feasible with the preliminary results appear to be encouraging. Link will provide a preliminary evaluation of the existing structures to ascertain whether it would be possible to stabilize the leaning abutment, determine what other improvements would be necessary and receive permission from all regulatory agencies with jurisdiction over what would be allowed before the Road Commission decides whether or not to pursue this option.

Adopt Resolution: Infrastructure Investment and Jobs Act Bridge Improvement Program participation: In a letter dated July 25, 2022 from the County Road Association, it was announced a new funding opportunity for a third Bridge Bundling for certain qualifying bridges, which the Nostwick Bridge qualifies. In order to be included with the MDOT application, the Board is being asked to adopt a Resolution and send it into the CRA by the end of the day August 1st to formally apply for this program.

Motion by Commissioner Bowers supported by Commissioner Rosa to adopt the "Resolution to Provide 20% Construction Match for the Infrastructure Investment and Jobs Act Bridge Improvement Program" which reads as follows:

**WHEREAS**, the county road agencies of Michigan are responsible for 75% of the state's roads and 52% of the bridges, all of which are vital to Michigan's economic welfare and the safety of its residents and visitors; **WHEREAS**, 59% or over 3,300 bridges under county road agency control are in less than good condition; and,

**WHEREAS**, the Infrastructure Investment and Jobs Act (IIJA) provides funding for a bridge replacement, rehabilitation, preservation, protection and construction as part of the IIJA Bridge Improvement Program to modernize bridges and to make them safer for all users;

**NOW THEREFORE BE IT RESOLVED**, the Benzie County Road Commission hereby pledges to provide 20% of the construction cost as matching funds for Structure No. 766 Nostwick Road bridge spanning the Betsie River if Michigan receives an award from the IIJA Bridge Improvement Program fund.

**BE IT FURTHER RESOLVED**, the preliminary engineering costs and construction engineering costs will not be assessed against the county.

#### Platte River Elementary School buildings:

Now that the Road Commission has ownership of the property, staff asked the Board to cease exploring alternative options to salvage the structures and proceed with plans to demolish the buildings. With much of the building contents and fixtures have been removed, what is left is in rough shape. In addition, the building would have to be heated over the winter if there is any hope of deterring mold growth and decay of the interior finishes. Skeels pointed out it would be more costly to incorporate any part of the existing structures into the proposed new road commission buildings. Nedow offered the suggestion that if the current school buildings are demolished and the new road commission facility has been built, the Board could reserve part of the vacated existing property/buildings for community/public use. #### Item Before the Board:

Resolution 22-09: formally recognize the 25-ton weight restriction on Sutter Road in Lake Township: Skeels reported that he was unable to locate any documentation in our files indicating how or when the weight limit on Sutter Road was established. Without this verification, the Road Commission's corporate counsel informed Skeels the designation is not enforceable unless the Board chooses to adopt a resolution citing the applicable state statute formally recognizing the restriction.

Further discussion ensued, with comments provided by Rick Frank, who is questioning the validity of the designation given that heavy vehicles that exceed the posted weight restriction have been traversing the road making deliveries to Crystal Downs and other business entities. He also added that if he abides by the posted weight restriction, it could cost him significantly more to develop his parcel. Further discussion continued if a "no thru truck" designation would be appropriate.

Motion by Commissioner Rosa supported by Commissioner Beechraft to leave the 25-Ton restriction signs as is and to add "No Thru Trucks" signage with the weight restriction signs.

Discussion: Staff questioned if leaving the weight restriction signage as is would be warranted as the designation is not enforceable without adopting the resolution. It was questioned if the Road Commission erects "No Thru Trucks" in place of the weight restriction signs, would the designation be enforceable without a formal adopted resolution, or would it be up to Lake Township to enforce their "No Thru Truck" ordinance (adopted by the Township several years earlier).

Appointments: Met with Jerry and Cheri Salenski, who reside at 12716 Brownell Road. Skeels stated that after he had spoken to Cheri and Kelly earlier, he had contacted a local geotechnical engineering firm to evaluate the situation and provide their recommendation(s) to stabilize the hillside. Skeels concluded his remarks by stating the Road Commission would be keeping the Salenskis advised as to what can be done to remediate the problem and stabilize the hillside.
